



This products 5 years warranty is not transferable nor is it valid unless the original purchaser sends to **Teleland** the fully filled in warranty card within one month of purchase.

This document comprises a warranty offered only to the original purchasers and is not transferable to any third party whatsoever.

1. Warranty

Subject to the schedule set out below and acceptance of this warranty by the original purchaser of the product. **Teleland** products carry a 5 years warranty that is to the original purchaser of each new product if stated when purchased. This applies to LCD and plasma televisions only. All other items and accessories are excluded from the 5 years warranty, regardless if they were purchased separately or with the TV and will only be supplied with their manufacturer's warranty.

2. Warranty time

Warranty expires exactly 5 years from the date of delivery. **Teleland** holds no responsibility of the product when under the manufacturer's warranty. **Teleland** will uphold the remaining time of the 5 years warranty the day after the last day of the manufacturer's warranty.

3. Exclusions

This warranty does not extend to, and will be void in respect of any products which have been subject to misuse, neglect, accidental damage, fire, improper modification, use in violation of the instructions furnished by the manufacturer or repaired by an unauthorized third party.

The original purchaser's rights under this warranty are expressly provided above. **Teleland** shall not be liable for any costs, expenses, or damage whatsoever other than the repair or replacement of the product as provided above including any loss of profits or other damages resulting directly or indirectly from failure or defect of the product, save for any liabilities which cannot be disclaimed or limited by law.

4. Returns

Products returned to **Teleland** must be pre authorised by **Teleland** or one of its agents authorised for this purpose. The original purchaser must send with the product proof of purchase and any relevant RMA forms issued by **Teleland**. The product shall be sent prepaid insured and packaged for safe shipment by the original purchaser which can be arranged by **Teleland** if necessary. All costs for this are to be born by the original purchaser.

5. Accepting this warranty

This document accompanies a warranty registration document which gives the original purchaser the details for registration by post. The original purchaser accepts and agrees that the original purchaser shall have accepted this warranty.
